I. PERFORMANCE WORK STATEMENT

A. The purpose of this firm fixed price contract is for Xerox photocopiers maintenance and repair services. Contractor's maintenance and repair services are to be provided to the American Embassy in Bamako, Mali. This is a fixed price contract with a fixed rate per machine covered. Some copiers will remain in place for the life of this contract, while new ones may be added to the contract, and old ones removed from it.

B. The contract will be for a one-year period from the date of the contract award, with four-year options.

II. PRICING

Minimum: During this contract period, the Government shall place orders totaling a minimum of two copiers machines maintenance and repair per month. This reflects the contract minimum for this period of performance.

Maximum: The amount of all orders shall not exceed twelve copier machines maintenance and repair services per month. This reflects the contract maximum for this period of performance.

Value Added Tax: Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

The Contractor warrants that the prices quoted herein include all expenses incident to the services to be performed and materials to be provided. Payments shall be limited to actual services performed. No claim for any additional compensation shall be considered, unless it has been authorized by the Government in writing in advance. The Government shall not be responsible for any work performed which is not specifically provided for under the terms of this contract or authorized by the Government in writing in advance.

IV. PRICE ADJUSTMENTS

- A. The contract price may be increased or decreased if a law passed by the Malian Government requires a change in the wages of the Contractor employees providing direct services under this contract
- B. For the Contracting Officer to consider any request for price adjustments the Contractor shall demonstrate in writing:
 - (1) That the change in the law occurred subsequent to the award date of the contract; and
 - (2) That the change in the law could not have been reasonably anticipated prior to award of the contract; and
 - (3) The calculation on how the law affects the wages of persons providing direct services under this contract.
- C. The Contractor should present documentation that clearly supports any request for adjustment, including the calculation of the amount of contract price adjustment request. Retroactive adjustments will be considered only if the referenced law is effective retroactively. The documentation shall identify and provide appropriate portions of the text of the particular law upon which the request is based.
- D. Any request for adjustments shall be certified by signature by an officer or general partner of the Contractor having overall responsibility for the conduct of the Contractor’s affairs.
- E. No adjustment shall be made to the contract price that relates to any indirect, overhead, or fixed costs, profits or fees. Only changes in direct service labor wages that are mandated by the change in law shall be considered by the Government a basis for contract price changes.

- F. No request by the Contractor for an adjustment under this provision shall be allowed if asserted after final payment under this contract.

I. DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

The Contractor shall provide all necessary maintenance and repair services, and the man power for the maintenance of Xerox copiers at the United States Embassy, Bamako, Mali, as described in these specifications. The Embassy may, from time to time, add or remove some copiers from the list.

The Contractor shall furnish all managerial, administrative, direct labor personnel, materials, and transportation that are necessary to accomplish all work as required by this contract in accordance with the highest professional standards. Contractor employees shall be on site only for performance of contractual duties and not for other business purposes. The works to be performed under this contract includes the following:

- Monthly preventive maintenance work (12 visits per annum) including dust cleaning, verification, repairs, report, and recommendations.
- Prompt repair of copiers each time a break-down happens.

Performance requirements for required work are described below.

II. Personnel

The Contractor shall provide a qualified work force capable of providing the services specified in this contract. The Contractor shall ensure that all personnel assigned to this contract possess the skills and experience necessary for accomplishing their individual tasks. All personnel to be assigned to this contract must be approved by the Contracting Officer's Representative (COR). For this purpose, the Contractor shall provide within ten days of contract award a list of key personnel to be assigned and a statement of the personal qualification for each.

III. WORK REQUIREMENTS

- A. The Contractor shall provide monthly preventive maintenance visits for each machine covered by the contract. The visit schedule will be established by written agreement between the parties hereto.
- B. Monthly visits shall include cleaning of the machine, adjustment of or regulation of its functions, and replacement of any parts that are worn to the extent that they hinder proper functioning.
- C. The Contractor shall provide unscheduled maintenance visits for cleaning and adjustment when required, at no additional cost. Requests for such visits must be made by the Contracting Officer or the COR in writing or by phone.

- D. The Contractor shall provide prompt repair services for any covered machine not functioning properly. Such services must be requested by the Contracting Officer or the COR in writing or by phone. The Contractor shall respond and send personnel within 24 hours of such notification and shall provide immediate, same-day service whenever possible.
- E. The Contractor's workforce shall be on-site for contractual duties only and not for business or any other purposes unless specified by the COR.
- F. Within ten days of the effective date of the contract, the Contractor shall provide in writing a proposed schedule for regular monthly maintenance visits.
- G. The Contractor shall maintain a log for each covered machine, noting the dates of each service visit and adjustments/repairs performed.
- H. The Contractor shall submit a final report that details tasks performed on each copier after each monthly maintenance that is in addition to and different from the single handwritten receipt form.
- I. U.S. Government-furnished parts and suppliers are for use in machine in place at the U.S. Embassy. The Contractor shall be held accountable for all parts and suppliers and shall maintain accurate records of their use. The Government may deduct from contractor invoices the cost of all Government furnished materials drawn from the Embassy stock, but for which there are no records of installation or use.
- J. In accordance with FAR 52.216-18 ORDERING (OCT 1995), the designated ordering individual for this contract is the Contracting Officer.

III. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE.

The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. STANDARD.

The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

3. PROCEDURES.

- a. If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- b. The COR will complete appropriate documentation to record the complaint.

- c. If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
- d. If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- e. The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- f. If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- g. The COR will consider complaints as resolved unless notified otherwise by the complainant.
- h. Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue.
